Resolution No. 100, Series of 2018

RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO THE JJJ NEWSPAPERS AND MAGAZINE FOR THE SUPPLY AND DELIVERY OF NEWSPAPERS FOR THE PRESIDENTIAL MANAGEMENT STAFF (PMS) FROM 01 JANUARY TO 31 DECEMBER 2019

WHEREAS, the Administrative Management Office (ADMO) prepared the Terms of Reference (TOR) and purchase request for the supply and delivery of newspaper for the PMS with an Approved Budget for the Contract (ABC) of P246,576.00¹ (**Annex A**), which is included in the Indicative Annual Procurement Plan (APP) of the PMS for FY 2019 (**Annex B**);

WHEREAS, on 20 November 2018, the PMS-Bids and Awards Committee (BAC) posted/published the Request for Quotation (RFQ) for the said procurement project (**Annex C**)². The PMS-BAC also invited the following suppliers to submit their respective quotations/proposals: 1) JJJ Newspaper and Magazine; 2) H-Asia Newspaper & Magazines, Inc.; and, 3) Network Magazine Subscription Services Inc. However, only the JJJ Newspaper and Magazine and H-Asia Newspaper & Magazines, Inc. submitted its price quotation along with the attached eligibility requirements on 26 November 2018 (**Annex D**);

WHEREAS, per evaluation of the ADMO, which was received by the BAC Secretariat on 03 December 2018, while both suppliers complied with the eligibility and technical requirements of the PMS, the JJJ Newspaper and Magazine's price quotation amounting to P201,231.00, which is within the ABC, is deemed the lowest calculated and responsive quotation (**Annex E**);

WHEREAS, the PMS-BAC finds the recommendation of the ADMO in strict accordance with Republic Act (RA) No. 9184 and its 2016, Revised Implementing Rules and Regulations; and

WHEREAS, Section 12 of R.A. No. 9184 mandates that the PMS-BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the PMS-BAC, hereby **RECOMMEND** to the Acting Deputy Head pursuant to Office Order No. 2018-011³, the following:



- (2) **GRANT OF AUTHORIZATION** for the BAC Chairperson to sign the corresponding Notice of Award and Notice to Proceed to implement this Resolution.




