Resolution No. 104, Series of 2021

RECOMMENDING THE AWARD OF CONTRACT TO THE AVID SALES CORPORATION FOR THE PROCUREMENT OF NINE (9) UNITS OF SHORT THROW PROJECTORS

WHEREAS, the Knowledge Management Service submitted the Terms of Reference (TOR) and Purchase Request (PR) for the procurement of nine (9) units of short throw projectors (**Annex A**) with an Approved Budget for the Contract (ABC) amounting to PhP2,790,000.00, which is included in the Supplemental Annual Procurement Plan No. 3 for FY 2021¹ (**Annex B**);

WHEREAS, Section 10, Article IV of Republic Act (R.A.) No. 9184² provides that all procurement shall be done through Competitive Bidding, except as provided for in Article XVI thereof;

WHEREAS, in compliance therewith, the PMS-BAC Secretariat posted the Invitation to Bid on the prescribed online platforms on September 15, 2021 and invited suppliers³ to participate in the procurement at hand (**Annex C**). Of those invited, only the Avid Sales Corporation (ASC) purchased the bid documents and submitted its bid offer⁴ within the deadline set for the submission and receipt of bids, which was scheduled on October 7, 2021, 10:00 AM;

WHEREAS, during the Opening of Bids⁵, the ASC was declared "eligible" for having submitted complete eligibility and technical requirements. Consequently, its financial envelope was opened, which revealed a bid offer in the amount of PhP2,538,000.00 (**Annex D**):

WHEREAS, considering that the bid of ASC was declared as the single calculated bid (SCB), the same was subjected to post-qualification evaluation by the Technical Working Group for Information Technology (TWG-IT) to determine its compliance and responsiveness to all the requirements and conditions specified in the bidding documents;

WHEREAS, as reflected in the technical and financial post-qualification evaluation reports submitted by the TWG-IT to the BAC Secretariat on October 13 and 21, 2021, respectively, the ASC's offer amounting to PhP2,538,000.00 was determined to be the single calculated and responsive bid for having complied with all the requirements of the PMS for the said procurement activity (**Annex E**); and

RECOMMENDING THE AWARD OF CONTRACT TO THE AVID SALES CORPORATION FOR THE PROCUREMENT OF NINE (9) UNITS OF SHORT THROW PROJECTORS

WHEREAS, the PMS BAC finds the recommendation of the TWG-IT in strict accordance with R.A. No. 9184 and its 2016 RIRR; and

WHEREAS, Section 12.1 (h) of the 2016 RIRR of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his duly authorized representative.

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the PMS BAC, hereby **RECOMMEND** to the Deputy Head⁶ the following:

- 1) **AWARD OF CONTRACT** to the Avid Sales Corporation for the procurement of nine (9) units of short throw projectors in the amount of PhP2,538,000.00, inclusive of all applicable taxes and fees; and,
- 2) **GRANT OF AUTHORIZATION** to the PMS-BAC Chairperson, or in his absence, the BAC Vice-Chairperson, to sign the corresponding Notice of Award and the Notice to Proceed to implement this Resolution.




