Resolution No. 44, Series of 2021

RECOMMENDING THE AWARD OF CONTRACT TO THE CHEMTECH MEDICAL SUPPLY FOR THE PROCUREMENT OF 1,600 PIECES OF RAPID COVID-19 IMMUNOGLOBULIN M (IgM) AND IMMUNOGLOBULIN G (IgG) TEST KITS

WHEREAS, the Safety, Wellness, and Resiliency Team (SWeRTe) submitted to the PMS-Bids and Awards Committee (PMS-BAC) the Terms of Reference (TOR) and Purchase Request (PR) for the procurement of 1,600 pieces of Rapid COVID-19 IgM and IgG Test Kits (**Annex A**) with an Approved Budget for the Contract (ABC) in the Updated PMS' Annual Procurement Plan for Fiscal Year (FY) 2021, amounting to PhP940,000.00¹ (**Annex B**);

WHEREAS, Item No. 8, Annex H of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184² provides that the procuring entity may resort to small value procurement to promote economy and efficiency if the ABC does not exceed PhP1,000,000.00 (**Annex C**);

WHEREAS, on 29 June 2021, the PMS-BAC posted a Request for Quotation, which was responded to by three (3) suppliers³ on or before the set deadline on 09 July 2021 (**Annex D**). Of the three (3) suppliers, only the Bigvision International Trade & Industries Corp. and Chemtech Medical Supply were deemed eligible to be evaluated by the end-user for submitting the complete eligibility documents (**Annex E**), with the following offers:

WHEREAS, on 14 July 2021, the SWeRTe forwarded to the PMS-BAC Secretariat its evaluation, stating that the offers of both suppliers are compliant with the PMS' terms and conditions in the TOR, with the Chemtech Medical Supply's offer, amounting to PhP352,000.00, inclusive of appropriate taxes and fees, deemed to be the most advantageous to the Government, thereby rendering the same as the **lowest calculated and responsive quotation** (**Annex F**);

WHEREAS, the PMS-BAC finds the evaluation/recommendation of the end-user to be in strict accordance with R.A. No. 9184 and its 2016 RIRR; and,

WHEREAS, Section 12.1(h) of the 2016 RIRR of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.



NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the Members of the PMS-BAC, hereby **RECOMMEND** to the Acting Deputy Head,⁴ the following:

- (1) **AWARD OF CONTRACT** to the Chemtech Medical Supply for the procurement of 1,600 pieces of Rapid COVID-19 IgM and IgG Test Kits, amounting to PhP352,000.00, inclusive of all applicable taxes and fees; and
- (2) **GRANT OF AUTHORIZATION** to the PMS-BAC Chairperson, or in his absence, the Vice-Chairperson, to sign the Notice of Award and the Notice to Proceed to implement this Resolution.




