Resolution No. 58, Series of 2018

RECOMMENDING THE AWARD OF CONTRACT TO MR. ENRICK A. MIRADOR AS THE PMS' SYSTEM ANALYST AND DEVELOPER FOR SIX (6) MONTHS

WHEREAS, the Information and Communication Technology Service (ICTS) prepared the Terms of Reference (TOR) and purchase request for the engagement of system analyst and developer who shall perform the entire development life cycle: planning, analysis, design, development, stabilization, deployment and maintenance. He shall be responsible in all his project and system documentation and demo/presentation to the end-user. Furthermore, he shall recommend protocols, standards and introduce innovation and continual improvement of organization IT processes related to system development. (**Annex A**). Said procurement project is included in the PMS Annual Procurement Plan (APP) for CY 2018 with an Approved Budget for the Contract (ABC) amounting to P300,000.00¹ (**Annex B**);

WHEREAS, Section 53.7, in relation to Section 48.1, of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 provides that *the procuring entity may hire consultants to do work that is highly technical to promote economy and efficiency. The term of the consultant shall, at the most, be on a six (6) month basis, renewable at the option of the appointing Head of the Procuring Entity, but in no case shall exceed the term of the latter*;

WHEREAS, in a Memorandum received by the Chairperson, Bids and Awards Committee (BAC) on 13 July 2018, the Technical Working Group for Information Technology (TWG for IT) recommended the engagement of Mr. Enrick A. Mirador as the PMS analyst/developer, based on expected provisions/deliverables (**Annex C**);

WHEREAS, the BAC, after its validation that Mr. Enrick A. Mirador is legally, technically and financially capable to undertake and fulfill the consultancy work based on the TOR, finds the above recommendation to be in strict accordance with RA No. 9184 and its 2016 Revised IRR;

WHEREAS, Section 12 of RA No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.





- (2) **GRANT OF AUTHORIZATION** to the BAC Chairperson to sign the Notice of Award and Notice to Proceed to implement this Resolution.


