Resolution No. 65, Series of 2018

**RECOMMENDING THE AWARD OF CONTRACT TO THE SOMOLI ASIA
VENTURES, INC. FOR THE PROCUREMENT OF 500 UNITS OF SMART BAGS
AS PMS TOKEN FOR CY 2018**

WHEREAS, the Administrative Management Office (ADMO) submitted to the PMS Bids and Awards Committee (BAC) the Terms of Reference (TOR) (**Annex A**) and purchase request for the procurement of 500 units of Smart Bags as PMS tokens for CY 2018 with an Approved Budget for the Contract amounting to Php850,000.00, which is included in the updated 2018 PMS Annual Procurement Plan (APP)¹ (**Annex B**);

WHEREAS, the Request for Quotation for the said procurement project was posted on the PhilGEPS website on 09 August 2018. (**Annex C**). Three (3) prospective suppliers were invited to submit their respective price quotations, viz.: a) Somoli Asia Ventures, Inc., b) AGAVE Trading, and c) IPOWER Products and Systems, Inc.;

WHEREAS, only the Somoli Asia Ventures, Inc. submitted its price quotation (**Annex D**) for the said procurement project with attached eligibility requirements;

WHEREAS, on 24 August 2018, the TWG/end-user submitted the result of their evaluation and recommendation. The Somoli Asia Ventures, Inc. was determined as the single calculated responsive quotation offering the amount of Php840,000.00, inclusive of taxes. The comprehensive evaluation revealed the said supplier has complied with all the requirements specified in the TOR. (**Annex E**);

WHEREAS, the PMS-BAC finds the recommendation of the TWG/end-user in strict accordance with Republic Act (R.A.) No. 9184 and its 2016 Revised Implementing Rules and Regulations (RIRR); and

WHEREAS, Section 12.1(h) of the 2016 RIRR of R.A. No. 9184 mandates that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the PMS-BAC, hereby **RECOMMEND** to the Acting PMS Deputy Head pursuant to Office Order No. 2018-011², the following:






