Resolution No. 68, Series of 2018

RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO THE CO BAN KIAT HARDWARE, INC. FOR THE PROCUREMENT OF EIGHTEEN (18) CARRY-ON CASES

WHEREAS, the Administrative Management Office (ADMO) prepared the Terms of Reference (TOR) and the purchase request (**Annex A**) for the procurement of eighteen (18) carry-on cases to be used in transporting various equipment and tools during Presidential engagements with an Approved Budget for the Contract (ABC) amounting to PhP500,000.00, which is included in the Updated PMS Annual Procurement Plan for CY 2018 (APP)¹ (**Annex B**);

WHEREAS, under Item No. 8, Annex H of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184², the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed PhP 1,000,000.00 (**Annex C**);

WHEREAS, on 23 August 2018, the PMS-BAC posted the request for quotation³ and invited three suppliers to participate in the said procurement, namely: (a) Ban Bee Commercial Company, Inc.; (b) St. Christ International Trading; and (c) Co Ban Kiat Hardware, Inc. Only the Co Ban Kiat Hardware, Inc. submitted a price quotation that is within the ABC with attached eligibility requirements (**Annex D**);

WHEREAS, on 04 September 2018, the ADMO forwarded to the BAC Secretariat its evaluation which, among other things, found the offer of the Co Ban Kiat Hardware, Inc. to be compliant with its TOR. Its price quotation amounting to PhP426,600.00, inclusive of all government taxes and fees, which is within the ABC, is still the most advantageous to the Government thereby rendering the same as the single calculated responsive quotation (**Annex E**);

WHEREAS, the BAC finds the recommendation of the ADMO in strict compliance with RA No. 9184 and its Revised IRR; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.





- (1) **AWARD OF CONTRACT** to the Co Ban Kiat Hardware, Inc. for the procurement of eighteen (18) carry-on cases to be used in transporting various equipment and tools during Presidential engagements, in the amount of PhP426,600.00, inclusive of all government taxes and fees; and
- (2) **GRANT OF AUTHORIZATION** for the BAC Chairperson to sign the Notice of Award and Notice to Proceed to implement this Resolution.


