Resolution No. 74, Series of 2018

RECOMMENDING THE AWARD OF CONTRACT TO LARICEL'S JEWELRY FOR THE PROCUREMENT OF TOKENS OF APPRECIATION FOR THE GOVERNMENT LOYALTY AND SERVICE AWARDEES FOR CY 2018

WHEREAS, the Human Resource Development and Management Office (HRDMO) prepared the Terms of Reference and purchase request for the procurement of tokens of appreciation for the government loyalty and service awardees for CY 2018 (**Annex A**) with an Approved Budget for the Contract (ABC) amounting to PhP1,672,450.00, which is included in the Updated Annual Procurement Plan for CY 2018 (APP)¹ (**Annex B**);

WHEREAS, from 26 April 2018 to 14 May 2018, the PMS-Bids and Awards Committee (PMS-BAC) invited all interested manufacturers, suppliers or distributors to participate in the competitive bidding for the abovementioned procurement activity² (**Annex C**);

WHEREAS, only Laricel's Jewelry (Laricel's) purchased bid documents for the said procurement;

WHEREAS, during the submission and opening of bids on 16 May 2018³, the PMS-BAC after using a non-discretionary "pass/fail" criteria declared the Laricel's Jewelry "eligible" for having submitted all the required eligibility documents and complied with the specifications as indicated in the bidding documents (**Tab D**).⁴ Thus, its financial proposal was opened;

WHEREAS, the Laricel's submitted its bid in the amount of PhP1,375,000.00 (**Annex E**);

WHEREAS, considering that the bid offer of Laricel's is the single calculated bid, said bid was subjected to post-qualification to determine its compliance and responsiveness to all the requirements and conditions specified in the bidding documents;

WHEREAS, on 25 September 2018, the Technical Working Group/end-user (TWG/end-user) forwarded to the BAC Secretariat its evaluation which, among other things, found the offer of the Laricel's to be compliant with its TOR. Its bid offer amounting to PhP1,375,000.00, inclusive of all government taxes and fees, which is within the ABC, is still the most advantageous to the Government thereby rendering the same as the single calculated and responsive bid;

WHEREAS, the PMS-BAC finds the recommendation of the BAC Secretariat and the TWG/end-user in accordance with RA No. 9184 and its 2016 Revised IRR (**Annexes F, G, and H**)⁵; and






- (1) **AWARD OF CONTRACT** via competitive bidding to the Laricel's Jewelry which submitted the single calculated and responsive bid for the procurement of tokens of appreciation for the government loyalty and service awardees for CY 2018 in the amount of PhP1,375,000.00, inclusive of all appropriate taxes and fees; and
- (2) **GRANT OF AUTHORIZATION** for the BAC Chairperson to sign the Notice of Award and Notice to Proceed to implement this Resolution.


