Resolution No. 78, Series of 2018

RECOMMENDING THE AWARD OF CONTRACT VIA SMALL VALUE PROCUREMENT TO THE YNZAL MARKETING CORP. FOR THE SUBSCRIPTION TO A CLOUD-BASED MULTIMEDIA EDITING TOOL FOR A PERIOD OF ONE (1) YEAR

WHEREAS, the Information Technology Office (ITO) prepared the Terms of Reference (TOR) and the purchase request (**Annex A**) for the subscription to a cloud-based multimedia editing tool for one (1) year with an Approved Budget for the Contract (ABC) amounting to PhP490,000.00, which is included in the Updated PMS Annual Procurement Plan for CY 2018 (APP)¹ (**Annex B**);

WHEREAS, under Item No. 8, Annex H of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184², the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed PhP 1,000,000.00 (**Annex C**);

WHEREAS, on 21 September 2018, the PMS-BAC posted the request for quotation³ and invited three suppliers to participate in the said procurement, namely: (a) Tiger Consulting and Software Development, Inc.; (b) First Data Corp.; and (c) Ynzal Marketing Corp. Only the Ynzal Marketing Corp. submitted a price quotation that is within the ABC with attached eligibility requirements (**Annex D**);

WHEREAS, on 28 September 2018, the TWG for IT and Communications (TWG for ITC)/end-user forwarded to the BAC Secretariat its evaluation which, among other things, found the offer of Ynzal Marketing Corp. to be compliant with its TOR. Its price quotation amounting to PhP490,000.00, inclusive of all government taxes and fees, which is within the ABC, is still the most advantageous to the Government thereby rendering the same as the single calculated responsive quotation (**Annex E**);

WHEREAS, the BAC finds the recommendation of the TWG for ITC/end-user in strict compliance with RA No. 9184 and its Revised IRR; and

WHEREAS, Section 12 of RA No. 9184 provides that the BAC shall recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.



NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the Members of the PMS-BAC, hereby **RECOMMEND** to the Acting PMS Deputy Head pursuant to Office Order No. 2018-011⁴, the following:


- (1) **AWARD OF CONTRACT** to the Ynzal Marketing Corp. for the subscription to a cloud-based multimedia editing tool for one (1) year⁵, in the amount of PhP490,000.00, inclusive of all government taxes and fees; and
- (2) **GRANT OF AUTHORIZATION** for the BAC Chairperson to sign the Notice of Award and Notice to Proceed to implement this Resolution.
