INVITATION TO BID

The Office of the President-Presidential Management Staff (OP-PMS), through its Bids and Awards Committee (BAC), hereby invites all eligible suppliers to bid for the following:

NAME OF PROJECT	: PROCUREMENT FOR THE SUPPLY, DESIGN, DELIVERY AND INSTALLATION OF FIXED AND HYDRAULIC SECURITY BOLLARDS FOR THE PRESIDENTIAL MANAGEMENT STAFF BUILDING
LOCATION	: AAP Tower, No. 683 Aurora Boulevard, Barangay Mariana, Quezon City
APPROVED BUDGET	: PhP5,305,000.00
FUNDING SOURCE	: General Appropriations Act of 2020
BRIEF DESCRIPTION	: The retrofitting and restoration works of the PMS Building are in its final stages, transforming it into smart, intelligent, green and disaster-resilient structure conducive to creative thinking, inspires employee, and maximizes productivity. To ensure safety and security of the PMS Building and its personnel, the PMS Management realized the need to install security bollards at the PMS Building frontage to provide protection and safety against traffic accidents/crashes, prevent vehicle ram-raiding attacks, and in more extreme cases to provide defense against security attacks/threats.

Bidders may bid and should have completed, within the last three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents particularly in the Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedure using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (Revised IRR) of Republic Act No. (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act No. (CA) 138.

Interested bidders may obtain further information from the PMS-BAC Secretariat and inspect the Bidding Documents at the OP-PMS temporary office space address indicated above during workdays from **10:00 AM to 6:00 PM**. The complete set of Bidding Documents, with prescribed forms to be used, may be purchased by interested Bidders at the same address and upon payment of a non-refundable amount of **PhP10,000.00**.

It may also be downloaded from the website of the Philippine Government Electronic Procurement System (<http://www.philgeps.net/>), provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

Bids may be submitted online³ via bac@pms.gov.ph, provided that the email is encrypted, the file is in a .zip format and password-protected. The password to access the file shall only be disclosed by the bidders during the actual bid opening.

Bids must be submitted at the latest **one hour before the deadline for the opening of bids (or at 4:00 PM of 03 November 2020)**, accompanied by a bid security in any of the acceptable forms and in the amount stated in the Instruction to Bidders. The bids shall be opened in the presence of the bidders or their duly authorized representatives who shall attend at the virtual meeting itself. Late bids shall not be accepted.

The OP-PMS reserves the right to reject any or all Bids, to waive any minor defects therein, to annul the bidding process, to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder(s), and to accept only the offer that is most advantageous to the Government. The PMS assumes no responsibility whatsoever to compensate or indemnify Bidders for any expenses incurred in the preparation of their Bids.
