Resolution No. 83, Series of 2018

**RECOMMENDING THE AWARD OF CONTRACT TO
MR. ALLAN D. FABULAR AS THE PMS DATABASE ADMINISTRATOR
AND DEVELOPER FOR SIX (6) MONTHS**

WHEREAS, the Information Technology Office prepared the Terms of Reference (TOR) and purchase request for the engagement of a database administrator and developer who shall, among others, craft a database development framework, convert existing data tables into SQL and develop necessary systems to generate reports, and harmonize databases (**Annex A**);

WHEREAS, the aforesaid procurement is included in the PMS Annual Procurement Plan for CY 2018 with an Approved Budget for the Contract (ABC) amounting to P600,000.00¹ (**Annex B**);

WHEREAS, Section 53.7, in relation to Section 48.1, of the 2016 Revised Implementing Rules and Regulations (Revised IRR) of Republic Act (R.A.) no. 9184 provides that the procuring entity may hire consultants to do work that is highly technical to promote economy and efficiency, provided that the term of the consultant shall, at the most, be on a 6-month basis, renewable at the option of the appointing Head of the Procuring Entity, but in no case shall exceed the term of the latter;

WHEREAS, in a memorandum received by the Chairperson, PMS Bids and Awards Committee (PMS-BAC) on 27 September 2018, the Technical Working Group for Information Technology recommended the engagement of **Mr. Allan D. Fabular** as the PMS Database Administrator and Developer for six (6) months, based on expected provisions/deliverables (**Annex C**);

WHEREAS, the PMS-BAC, after its validation that Mr. Fabular is legally, technically, and financially capable to undertake and fulfill the consultancy work based on the TOR, finds the above recommendation to be in strict accordance with R.A. no. 9184 and its 2016 Revised IRR;

WHEREAS, Section 12 of R.A. 9184 mandates that the PMS-BAC shall recommend the award of contract to the Head of the Procuring Authority or his duly authorized representative;

¹ The ABC therefor, pegged at P600,000.00, is inclusive of two (2) 6-month contracts for the engagement of a database administrator and developer.

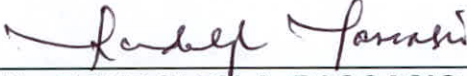
NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the Members of the PMS-BAC, hereby recommend to the Acting Deputy Head pursuant to Office Order no. 2018-011², the following:

- 1) **AWARD OF CONTRACT** to Mr. Allan D. Fabular for the engagement of his services as the PMS Database Administrator and Developer, in consideration of P300,000.00 for six (6) months, inclusive of appropriate taxes and fees;
- 2) **GRANT OF AUTHORIZATION** to the PMS-BAC Chairperson to sign the Notice of Award and Notice to Proceed to implement this Resolution.

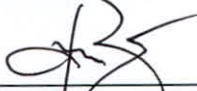

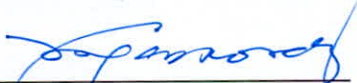
