**PMS-BIDS AND AWARDS COMMITTEE**  
**Resolution No. 94, Series of 2021**

**RECOMMENDING THE AWARD OF CONTRACT TO THE NEW A.G. STYLIST FURNITURE FOR THE SUPPLY AND DELIVERY OF 39 UNITS OF OPEN-TYPE STEEL SHELVES**

**WHEREAS**, the Knowledge Management Service (KMS) submitted to the PMS-Bids and Awards Committee (PMS-BAC) the Terms of Reference (ToR) and Purchase Request (PR) for the supply and delivery of 39 units of Open-type Steel Shelves (**Annex A**) with an Approved Budget for the Contract (ABC) in the PMS Supplemental Annual Procurement Plan No. 3 for Fiscal Year (FY) 2021, amounting to PhP232,000.00<sup>1</sup> (**Annex B**);

**WHEREAS**, Item No. 8, Annex H of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184<sup>2</sup> provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed PhP1,000,000.00 (**Annex C**);

**WHEREAS**, the PMS-BAC Secretariat posted a request for quotation on September 10, 2021<sup>3</sup> (**Annex D**), and invited 25 suppliers.<sup>4</sup> Six (6) suppliers responded, and upon the initial assessment thereof, the PMS-BAC Secretariat found four (4) suppliers compliant with the requirements set forth under Item II.F, Appendix A, Annex H of the 2016 RIRR of R.A. No. 9184 (**Annex E**), thus eligible to be evaluated by the end-user. The summary of the evaluation is as follows:

**WHEREAS**, on September 21, 2021, the KMS forwarded to the PMS-BAC Secretariat its evaluation, stating that the offer of the New A.G. Stylist Furniture for the supply and delivery of 39 units of Open-type Steel Shelves, amounting to PhP195,000.00,

inclusive of all applicable taxes and fees, is compliant with the PMS' terms and conditions in the ToR and well within the ABC, thereby rendering the same as the **lowest calculated and responsive quotation** (Annex F);

**WHEREAS**, the PMS-BAC finds the evaluation/recommendation of the end-user to be in strict accordance with R.A. No. 9184 and its 2016 RIRR; and,

**WHEREAS**, Section 12.1(h), Rule V of the 2016 RIRR of R.A. No. 9184 empowers the BAC to recommend the award of contract to the Head of the Procuring Entity or his/her duly authorized representative.

**NOW, THEREFORE**, for and in consideration of the foregoing, **WE**, the Members of the PMS-BAC, hereby **RECOMMEND** to the Deputy Head,<sup>8</sup> the following:

- (1) **AWARD OF CONTRACT** to the New A.G. Stylist Furniture for the supply and delivery of 39 units of Open-type Steel Shelves, amounting to PhP195,000.00, inclusive of all applicable taxes and fees; and
- (2) **GRANT OF AUTHORIZATION** to the PMS-BAC Chairperson, or in his absence, the Vice-Chairperson, to sign the Notice of Award and the Notice to Proceed to implement this Resolution.


