Contract for Goods

This CONTRACT executed on <u>NOV 9.5 2024</u> between the OFFICE OF THE PRESIDENT-PRESIDENTIAL MANAGEMENT STAFF (OP-PMS), represented by Atty. RODOLFO JOHN ROBERT C. PALATTAO IV, Undersecretary for Integrated Operations (hereinafter called the "Entity") and the AMERICAN TECHNOLOGIES INC. represented by Ms. ALICIA JUNIZEL R. SY, Senior Account Manager, with office address at #5 Ideal St. cor. McCollough St., Barangay Addition Hills, Mandaluyong City (hereinafter called the "Supplier").

WHEREAS, upon invitation of the Entity, the Supplier submitted a bid for the procurement of Hyperconverged Infrastructure (HCI) back up appliances for the OP-PMS Central Office (CO) and Sub-Central Unit (SCU) in the amount of Seven Million One Hundred Eighty-Six Thousand Seven Hundred Twenty-One Pesos and One Centavo (Php7,186,721.01), inclusive of all appropriate taxes and fees (hereinafter called the "Contract Price"), which the Entity subsequently accepted pursuant to Bids and Awards Committee Resolution No. 79, series of 2024.

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

- The following documents shall form part of this Contract in accordance with Section 37.2.3 of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184, viz:
 - (a) The Entity's Terms of Reference, attached as Annex A;
 - (b) The Entity's Invitation to Bid published on 21 June 2024, attached as Annex B;
 - (c) The Technical Specifications submitted by the **Supplier** on 12 July 2024, attached as **Annex C**;
 - (d) The Bid Form with Price Schedule for Goods submitted by the Supplier on 12 July 2024, attached as Annex D;
 - (e) The Schedule of Requirements submitted by the **Supplier** on 12 July 2024, attached as **Annex E**; and
 - (f) The Notice of Award, attached as Annex F;
- 2. In consideration of the Contract Price to be paid by the Entity to the Supplier as hereinbefore mentioned, the Supplier hereby covenants with the Entity to deliver the goods, and remedy defects thereof, if any, in conformity with the stipulations of the Contract in all respects, without prejudice to any other obligations that may arise pursuant to the provisions of applicable laws.
- The delivery of the HCI backup appliances and their accessories to the OP-PMS CO and SCUs shall be within 120 calendar days upon receipt of the corresponding Notice to Proceed (NTP). Delay in the delivery shall be subject to a penalty equivalent to 1/10 of 1% of the cost of undelivered item/s for every day of delay.
- 4. All equipment, components, system software, and parts furnished and installed by the **Supplier** shall be guaranteed against defects and on-site warranty services for three (3) years.

The labor to repair, reprogram, or replace these components shall be furnished by the **Supplier** during normal working hours at no additional cost to the OP-PMS for the duration of the warranty period.

- 5. Payment to the Supplier shall be made, subject to deduction of applicable taxes and five percent (5%) retention fee pursuant to Section 62 of the 2016 RIRR of RA No. 9184, upon the issuance of the Certificate of Acceptance and Completion of each delivery and submission of statement of account or billing upon completion of delivery and installation of HCI back up appliances in the respective locations.
- 6. Pursuant Executive Order No. 398 (s. 2005)¹ and Revenue Regulation No. 017-2024² the Supplier shall pay applicable taxes in full and on time and, prior to the final settlement of the contract, the Supplier shall present to the Entity an updated tax clearance from the Bureau of Internal Revenue (BIR) certifying that the Supplier has no outstanding tax liabilities; duly filed the latest income and business tax returns; and paid corresponding due thereon. Failure to do so will entitle the Entity to suspend the release of the final payment and/or retention money as tax lien on the Supplier.
