NOTICE OF NEGOTIATED PROCUREMENT

SUPPLY OF PETROLEUM, OIL, LUBRICANTS, VARIOUS VEHICLE SUPPLIES AND GENERAL SERVICING OF PMS VEHICLES THROUGH CREDIT FACILITY

Negotiated Procurement due to Two-Failed Biddings

1. The **Presidential Management Staff (PMS)**, intends to procure the **“Supply of Petroleum, Oil, Lubricants, various vehicle supplies and general servicing of PMS vehicles through credit facility”** with approved budget for the contract of **Six Million Five Hundred Thousand Pesos (PhP 6,500,000.00)**.
2. The PMS now invites technically, legally, and financially capable suppliers for the above-mentioned goods.
3. The procurement procedure that will be adopted is Negotiated Procurement considering that there has been two failure of biddings pursuant to Section 53.1 of the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the Government Procurement Reform Act (GPRA).

The procurement is restricted to Filipino citizens/sole proprietorships and organizations (i.e., partnerships, corporations, cooperatives and joint ventures) with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138).

The Bids and Awards Committee (BAC) will invite and engage in negotiations with a sufficient number of suppliers (at least three [3] suppliers of good standing) to ensure effective competition. **The selection of the successful offers shall be based on the best and final offer that will be submitted on a specified date, which should meet the PMS’ minimum technical requirements and does not exceed the ABC.**

4. Interested Bidders may obtain further information from the **BAC Secretariat** at the address given below from Monday to Friday at 8:00 am to 5:00 pm. **A Pre-Bid Conference for the said procurement shall be held on 17 September 2014 to clarify issues, if any.**
5. **The deadline for the submission of quotations/proposals is on 29 September 2014, 2:00 PM, which shall be delivered to the Office of the PMS BAC Chairman, 4th Floor, PMS Building, Arlegui Street, San Miguel, Manila. Late quotations /proposals shall not be accepted.**

6. **The opening of quotations/proposals shall be on 29 September 2014, 2:00 PM, to be held at the Legal Service Conference Room, 4th Floor, PMS Building, Arlegui Street, San Miguel, Manila.**
7. The PMS reserves the right to accept or reject any proposal and to annul the procurement process at any time prior to contract award, without thereby incurring any liability to the affected suppliers.
